Birth month expiration transition CFE Requirements

Completion of thirty-two (32) total continuing forensic education hours per 2-year license cycle

Normal rules—

Minimum sixteen (16) hours of the thirty-two (32) total must be discipline-specific training, peer-reviewed journal articles, and/or conference education hours. If a licensee is licensed in multiple forensic disciplines, at least eight (8) hours of discipline-specific training in each forensic discipline are required, subject to the provisions set forth in subsection (f) of this section.

The remaining sixteen (16) hours may be general forensic training, peer-reviewed journal articles, and/or conference education hours that include hours credited for the mandatory legal and professional responsibility training. Any additional disciplines specific hours (beyond the minimum sixteen (16) required) are also counted towards total thirty-two (32) required.

Temporary Exception to Continuing Forensic Education Requirements During January 2024 to December 2026 Transition from Application to Birthdate-Based Renewal Terms—

For any licensee who *has less than two years* to complete the continuing forensic education requirements in (g) of this section as a result of the transition from application-based renewal to birthdate-based renewal, the number of required continuing education hours in (g)(3)(A) and (g)(3)(B) for license renewal shall be pro-rated *based on the number of months* in the renewal term.

***During the transition, licensees can count hours from the license cycle before the transition period toward the transition license cycle.
