

ORDER GRANTING DEFENDANT COTIVITI, INC.'S MOTION TO DECLARE PLAINTIFF A VEXATIOUS LITIGANT

On the 23rd day of January 2024, this Court conducted a hearing on Defendant Cotiviti, Inc.'s Motion To Declare Plaintiff A Vexatious Litigant. All parties were present either through their respective counsel of record or *pro se*. After considering the Motion, as well as any response and reply, the evidence presented at the hearing, and arguments of counsel and parties, the Court finds that Plaintiff Alan Headman is a vexatious litigant in accordance with Tex. Civ. Prac. & Rem. Code § 11.054.

It is therefore ORDERED, ADJUDGED, and DECREED that the Motion in all respects is GRANTED;

It is further ORDERED, ADJUDGED, and DECREED that Plaintiff Alan Headman is found to be a Vexatious Litigant;

It is further ORDERED, ADJUDGED, and DECREED that Plaintiff Alan Headman must post security for the benefit of Cotiviti, Inc. in the amount of \$\frac{50,000.00}{}\$ within 30 days of this Order;

It is further ORDERED, ADJUDGED, and DECREED that the current proceedings are hereby stayed until Plaintiff Alan Headman posts the required security;

It is further ORDERED, ADJUDGED, and DECREED that Plaintiff Alan Headman is hereby prohibited from filing any new litigation in Texas as a *pro se* party without first obtaining the approval of a local administrative judge.
