The fees below are established by Court order or statute. As such, waivers for exemption from bond or security for court costs or appeals do not apply. Unpaid fees will be reported to the Court for action as appropriate. Motions accompanying other actions must be treated as separate.

The following fees apply except to persons exempt by law.

1. In the Courts of Appeals:

h. administering an oath with sealed certificate of oath	\$5
i. certified copy including certificate and seal	\$0.50 per page, \$5 minimum
j. comparing and certifying copy of document	\$0.50 per page, \$5 minimum
k. motion for rehearing	\$15
l. motion not otherwise listed	\$10
m. exhibit tendered for oral argument	\$25

3. In the Supreme Court and the Courts of Appeals:

paper copy, no certificate or seal*	\$0.10 per printed side of page or part of side of page
a. audio tape of oral argument (if available)*	\$1 per tape
b. VHS video tape of oral argument (if available)*	\$2.50 per tape
c. digital video disc of oral argument (if available)	\$3 per DVD
d. personnel, overhead, and document retrieval charge	see 1 Tex. Admin. Code § 70.3

A court may authorize additional, reasonable charges for personnel, overhead, or document retrieval for services provided by the clerk or by contract with an outside entity

4. Before the Judicial Panel on Multi-District Litigation:
