

THIRTEENTH COURT OF APPEALS  
SUMMER 2015 JUDICIAL INTERNSHIP PROGRAM

The Thirteenth Court of Appeals is accepting applications for its Summer 2015 Judicial Internship Program from first, second, and third-year law students. Applications will be accepted until March 6, 2015, or later at the discretion of the Court.

The Program consists of one six-week nonpaying internship which will run from Monday, May 18, 2015 through Friday, June 26, 2015 in the Edinburg and Corpus Christi offices of the Court. The starting date for the Program may be negotiable depending on the final exam schedule for applicant's law school.

Interns work as part of a team under the supervision of a Justice, Senior Attorney, and Junior Staff or Briefing Attorney. Interns selected for the Program will receive training and supervision in legal research and writing, and will perform hands-on work with the Justices and attorneys of the Court. Law students may receive course credit from their law schools. Applicants who are interested in the possibility of receiving course credit for an internship should contact their schools directly to determine the deadlines and requirements for obtaining course credit.

**Essential Job Functions.** Interns assist the Justices with general legal research, analysis, and writing, and participate in case conferences with the Court's Justices and attorneys. Interns may perform related work as required.

**Minimum Qualifications.** Applicants must possess knowledge of legal principles, practices, and proceedings, and skill in legal research, writing, and analysis. Applicants must be proficient in computer and word-processing skills and must be able to communicate clearly and effectively.

**Preferred Qualifications.** Strong preference is given to candidates with outstanding academic records, demonstrated writing ability, law review or journal experience, moot court or mock trial experience, and prior work for an appellate court or other appellate experience.

**Application Process.** Applicants should submit: (1) a cover letter; (2) resume; (3) law school transcript; (4) writing sample; and (5) two references or letters of recommendation to the Thirteenth District Court of Appeals, Attn: Cecile Foy Gsanger, Nueces County Courthouse, 901 Leopard Street, Tenth Floor, Corpus Christi, Texas 78401. Applicants should specify whether they are applying for an internship in Edinburg or Corpus Christi.
