## RULE 15. - APPLICATION FOR AND REFUSAL OF IV-D CHILD SUPPORT SERVICES

15.01 As provided in Section 15.03, all temporary and final orders (judgements) that provide for child support to be paid through the State Disbursement Unit, excluding modifications of orders prior to the effective date of this rule, shall be deemed to include an application for IV-D child support services provided by Dallas County and the Office of the Attorney General of Texas, pursuant to Chapter 231 of the Texas Family Code.

15.02 Unless required to accept IV-D child support services pursuant to other laws, a child support obligee entitled to receive services pursuant to this rule may decline services by filing a written Refusal of Child Support Services with the Dallas County Child Support Office. Refusal of IV-D child support services pursuant to this rule does not preclude a subsequent written application for IV-D services, however, it does preclude an obligee from re-entering this "Local Rule" program.

15.03 A Dallas County Family District Court may implement this rule by written notice to the Presiding Family Judge, District Clerk, Child Support Office and the IV-D Agency. The rule is effective in that Court on the tenth  $(10^{dh})$  day following written notice and applies only to temporary and final orders signed after that date.
