RE: Companion cases which were separated upon transfer

Dear Judge Phillips:

It has been brought to this Court's attention that our Court and the Twelfth Court of Appeals share several companion cases which have been separated during the transfer process pursuant to the Supreme Court's authority to equalize dockets.


I have discussed the problem with Judge Tom Ramey and in order that these companion cases may be reviewed by the same Court, we are requesting that the following cases (Twelfth Court of Appeals Nos. 12-92-025-CR & 12-92-120-CR) be transferred from the Twelfth Court of Appeals to the Eleventh Court of Appeals:

We are also requesting that Santa Fe Energy Resources, Inc. et al v. Buttes Resources Company, Eleventh Court of Appeals No. 11-92-154-CV, be transferred from the Eleventh Court of Appeals to the Twelfth Court of Appeals so that it may be reviewed by the same Court in which companion case Adobe Resources Corporation et al v. Buttes Resources Company, 12-91-185-CV, is pending. These cases involve the same parties and share a supersedeas bond. The Appellants have requested that both cases be heard by one Court. The Appellee has requested that, if any transfer is made, both cases should be heard by the Twelfth Court of Appeals.
