#### ORDER

On this day, the Court considered the Motion for Acceptance of Resignation as Attorney and Counselor at Law of Anton Paul Hajek III together with the Concurring Motion of the State Bar of Texas, and the Certification of the General Counsel of the State Bar of Texas. The Court has reviewed said Motions and Certification and finds each to be legally sufficient. The Court, being advised that such resignation is tendered in lieu of disciplinary action, and being of the opinion that such resignation is in the public interest and will meet the ends of justice, hereby concludes that the following order is appropriate.

IT IS ORDERED that the Law License of Anton Paul Hajek III of Bexar County, Texas, State Bar Card No. 08716630, heretofore issued by this Court, be cancelled and his name be dropped and deleted from the list of persons licensed to practice law in Texas, and that he shall hereafter exercise none of the privileges and prerogatives of the office of an attorney at law. Respondent, Anton Paul Hajek III, is hereby permanently prohibited, effective immediately, from practicing law in Texas, holding himself out as an attorney at law, performing any legal service for others, accepting any fee directly or indirectly for legal services, appearing as counsel or in any representative capacity in any proceeding in any Texas court or before any Texas administrative

body, or holding himself out to others or using his name, in any manner, in conjunction with the words "attorney", "counselor", or "lawyer".

MOVANT, the State Bar of Texas, moves the Court to accept the resignation of Anton Paul Hajek III, as Attorney and Counselor at Law, showing the Court:

I.

On or about March 11, 1991, the United States District Court, Western District of Texas, in Case No. SA-90-CR-248(3), convicted Respondent, Anton Paul Hajek III, of a felony involving moral turpitude, to wit: one (1) count of conspiracy to possess with intent to distribute a quantity of marijuana, in violation of 21 U.S.C. §841(a)(1). Respondent was sentenced to thirty-five (35) months imprisonment in the custody of the United States Bureau of Prisons, and assessed a fine in the amount of \$15,000.00.

II.

Movant would respectfully show that conspiracy to possess with intent to distribute, violation of 21 U.S.C. §841(a)(1) is a "serious crime" as defined in Article X, §26 of the State Bar Rules. Movant would respectfully show that as a matter of law, pursuant to State Bar Act, Tex. Gov't Code Ann., §81.078 (Vernon 1988), an order of disbarment may be entered on proof of a final conviction of any felony involving moral turpitude.

McCormack, General Counsel of the State Bar of Texas, in accordance with the Rules Governing the State Bar of Texas Article X, §15, hereby certify that there is currently a disciplinary proceeding pending against Anton Paul Hajek III, State Bar Card No. 08716630, in a lawsuit styled The State Bar of Texas v. Anton Paul Hajek III, Cause No. 67135219-91. On March 11, 1991, Anton Paul Hajek III was convicted of one (1) count of a felony offense involving moral turpitude, and was assessed a punishment of thirty-five (35) months imprisonment. As a matter of law pursuant to State Bar Act, Tex. Gov't Code Ann., §81.078 (Vernon 1988), Anton Paul Hajek III should be disbarred.
