

WAIVER OF COMPLIANCE WITH RULES OF JUDICIAL EDUCATION



Judges Granted Waivers from Rules of Judicial Education

May 26, 1993

A. Unconditional Waivers Granted:

1. **Smith, Earl W. - Justice (Retired), 3rd Court of Appeals**
Has accrued 9.0 of the required 16 hours for 1992.
Personal Medical Reasons.
2. **Ballew, Velma - City of Frost Municipal Judge**
Had not yet assumed duties as judge, and wasn't aware of education requirement until the Texas Municipal Courts Training Center notified her. Subsequently, she took a course for 32.0 hours of credit.

Maverick County Judge
Has accrued 0.0 of the required 16.0 hours for 1992.
Personal Medical Reasons.
2. **Christal, William R.**
Donely County Judge
Carried forward 8.0 hours from 1991 and accrued 4.0 hours for 1992 of the 16.0 required hours for 1992.
Personal Medical Reasons.
3. **Dougherty, Joe R.**
Rains County Judge
Carried forward 4.0 hours from 1991 and accrued 16.0 hours in 1992 of the required 30.0 hours for 1992.
No time because of duties.
4. **Fite, James, R.**
Madison County Judge
Carried forward 11.0 hours from 1991 and accrued 0.0 hours for 1992 of the required 16.0 hours for 1992.
No time because of duties.
5. **Gonzalez, Charles A.**
Judge, 57th District Court
Accrued 9.25 hours of the required 16.0 hours for 1992.
No time because of duties. Has stated in his letter that he is scheduled to take 9.0 hours of course credit in January, 1993.

6. **Preslar, Stephen F.**
Ch. Justice, 8th Court of Appeals
Carried forward 1.5 hours from 1991 and accrued 10.5 hours in 1992 of the 16.0 required hours for 1992.
Personal Medical Reasons.
7. **Stem, Robert M.**
Judge, 82nd District Court
Has accrued 12.75 of the required 16.0 hours for 1992.
No time since trying a capital murder case.
8. **Berchermann, David A. Jr.**
Judge, 37th District Court
Carried Forward 7.25 hours from 1991 and accrued 2.0 hours in 1992 of the required 16.0 hours for 1992. Has stated in his letter dated 3/1/93 that he will attend a course held 3/7-10/93 and receive 9.0 hours of credit.
9. **Tipps, Arthur**
Senior District Judge
Has carried forward 11.5 hours from 1991 and accrued 4.0 hours in 1992 of the required 16.0 hours. Has stated in his letter dated 3/15/93 that on 12/01/92 he accrued 3.0 hours from a video tape course but the provider failed to send him credit.
10. **Zach, Freddie**
Waller County Judge
Has carried forward 10.0 hours from 1991 and accrued 4.0 hours in 1992 of the required 16.0 hours. Has requested a waiver and advised that he received 4.0 credit hours in February which he would like applied to the 1992 requirement.
11. **Harmon, William T.**
Judge, 178th District Court
Has carried forward 4.0 hours of credit from 1991 and accrued 7.0 hours credit in 1992 of the required 16.0 hours. Sent letter dated 3/18/93 requesting that 5.25 hours received 3/5/93 at the Punishment, Prisons, and Parole Symposium apply toward his 1992 requirement.
