DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, C. Tom Zaratti, (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

II.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Harris County, Texas. An officer may serve citation on Respondent at his address located at 7434 Darnell, Houston, Harris County, Texas 77074.

On or about August 3, 1992, Melvin Ray Evans (hereinafter called "Evans") contacted David Myers (hereinafter called "Myers"), a Houston attorney, regarding representation at a hearing scheduled for the following day on a felony DWI charge pending against Evans. Evans was unable to speak directly to Myers, and could not receive confirmation from Myers' staff that Myers would represent him at the hearing. As a result, Evans contacted Respondent, who agreed to represent Evans and promised to appear at the hearing.

IV.

At the hearing on or about August 4, 1992, Respondent was not present when Evans' case was called by court clerk. However, when Evans noticed that Myers was present in the courtroom, Evans decided to hire Myers, and paid him \$50.00 in attorney's fees. Myers proceeded to represent Evans at the hearing and negotiated a plea bargain on his behalf.

V.

Respondent arrived at the hearing shortly after the matter was concluded and while Myers and Evans were still present at the courtroom. When Evans informed Respondent that he had hired Myers to represent him, Respondent showed Evans a tape recorder and informed him that he had recorded their telephone conversation the previous evening wherein Evans had agreed to hire him. Respondent threatened Evans with possible perjury charges in the event Evans did not hire Respondent to represent him. Evans, fearful of Respondent's threats, agreed to hire Respondent and paid him \$100.00 in attorney's fees, although Myers had already negotiated a plea bargain on Evans' behalf.

VI.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III., IV. and V. hereinabove which occurred on or after January 1, 1990, constitute conduct which

violates Rules 1.04(a) and/or 8.04(a)(3) of the Texas Disciplinary Rules of Professional Conduct.

VII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Judge Shelley P. Hancock filing a grievance on or about September 14, 1992.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
