### **DISCIPLINARY PETITION**

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Vincent Lannie, (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

П.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Harris County, Texas. An officer may serve citation on Respondent at his business address located at 3814 Highway 146, Baytown, Harris County, Texas 77520.

On or about April 9, 1992, Respondent represented Josephine Greene (hereinafter called "Greene") in a personal injury matter. On that day, Greene signed a "Case Disbursement Sheet" generated by Respondent as part of the settlement of her personal injury claim.

IV.

The funds from the settlement of the personal injury matter were distributed on or about May 14, 1992. At that time, Respondent withheld Five Thousand Forty and 00/100 (\$5,040.00) for payment to Greene's medical provider, Dr. James S. Golden (hereinafter called "Golden").

V.

Golden learned of the settlement of Greene's personal injury matter on or about February 8, 1993. At that point, Respondent had failed to forward to Golden the amount withheld from the settlement for the purpose of payment of Golden's services. Golden contacted Respondent on or about February 12, 1993, regarding the settlement of Greene's case and Respondent's failure to pay his bill. Golden finally received a payment of Five Thousand Forty Dollars and 00/100 (\$5,040.00) on or about March 10, 1993.

VI.

Thereafter, it was learned that the Respondent had allowed the Internal Revenue Service (hereinafter called "IRS") to levy on his escrow account. Respondent also withdrew money from his escrow account to pay directly to the IRS. This escrow account, no. 0001953400, located at the Texas National Bank in Baytown, Texas, contained funds belonging both to third parties and to clients of Respondent. In addition, Respondent made client advances from his escrow account and paid his telephone and electric bills from the account.

VI.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III., IV., V., and VI. hereinabove which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.14(b), 1.14(c), 8.04(a)(1) and/or 8.04(a)(3) of the Texas Disciplinary Rules of Professional Conduct.

VIII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Joseph Greene filing a complaint on or about February 25, 1993.

#### **SECOND CAUSE OF ACTION**

IX.

By letter dated March 22, 1993 and received by Respondent on or about March 24, 1993, the Grievance Committee for State Bar District 4H urged Respondent to provide information in response to a complaint presented against him by James S. Golden, which complaint was brought to the attention of the Office of the General Counsel of the State Bar of Texas by the filing of a complaint with the State Bar of Texas on or about March 2, 1993. Respondent thereafter knowingly failed to respond to a lawful demand for information from a disciplinary authority, to wit, the Grievance Committee for State Bar District 4H, thereby engaging in professional misconduct in violation of Rule 8.01(b) of the Texas Disciplinary Rules of Professional Conduct.

#### **PRAYER**

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
