DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Rand Mintzer, (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

П.

Respondent is an attorney licensed to practice law in the State of Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Harris County, Texas. An officer may serve citation on Respondent at 5900 Memorial Drive, Ste. 100, Houston, Harris County, Texas 77007.

On or about August 5, 1993, Louise Squires ("Squires") hired Respondent to represent her with regards to the death of her son, Victor Lee Bosh. In or about November, 1993, Allstate Insurance Company ("Allstate") settled with Squires with regards to Victor Lee Bosh's death. In or about December, 1993, William Bosh hired James Perry ("Perry") to represent him with regards to the death of his son, Victor Lee Bosh. On or about December 14, 1993, Perry mailed Chad Clark ("Clark"), an Allstate adjuster, a letter of representation. Thereafter, Clark contacted Perry and informed him that Allstate had previously settled with regards to Victor Lee Bosh's death and that an affidavit of heirship had been executed stating that Victor Lee Bosh had no heirs other than Squires. Clark also contacted Respondent and informed him of the letter of representation that he had received from Perry. Thereafter, Respondent, or an employee under his direction, prepared a document entitled "Full Release and Settlement Agreement" ("settlement agreement") which sought to settle all possible claims that existed between Squires and William Bosh with regards to Victor Lee Bosh's death and the settlement money that Squires had received from Allstate. On or about December 23, 1993, the settlement agreement was mailed to Squires with the instructions that William Bosh was to sign the agreement. Respondent failed to obtain the consent of Perry prior to instructing Squires to communicate with Perry's client, William Bosh, on matters within the scope of Perry's representation of William Bosh. On or about December 28, 1993, William Bosh signed the settlement agreement.

IV.

Such acts and/or omissions on the part of Respondent as are described in Paragraph V, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates

Rules 4.02(a) and 8.04(a)(1) of the Texas Disciplinary Rules of Professional Conduct.

V.

The complaint which forms the basis of this cause of action set forth above was brought to the attention of the Office of the General Counsel of the State Bar of Texas by James Perry filing a complaint on or about January 14, 1994.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
