## **DISCIPLINARY PETITION**

# TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Hugh T. Echols, Sr. (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Texas

Government Code Annotated §81.001, et seq. (Vernon 1988 and supp. 1994), the Texas

Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure.

The complaint that forms the basis of this Disciplinary Petition was filed on or after May 1, 1992.

II.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Harris County, Texas, and therefore venue is appropriate in Harris County, Texas, pursuant to Rule 3.03 of the Texas Rules of Disciplinary Procedure. Respondent may be served at his business address located at 6223 Richmond, Suite 302, Houston, Harris County, Texas,

#### III.

On or about October 14, 1993, Larry Reed Deen (hereinafter called "Deen") hired Respondent, through Respondent's legal assistant, Paul Kelley (hereinafter called "Kelley"), to represent him in a paternity suit, styled *In the Interest of La Shayvia A. Deen, a Minor Child*, Cause No. 93-37759, In the 246th Judicial District Court of Harris County, Texas. Deen paid Respondent \$700.00 for services to be rendered.

#### IV.

Kelley advised Deen that Respondent would file an answer denying the allegations and the judge would then order a blood test to establish paternity. Kelley further advised Deen that he did not have to attend the hearing that was scheduled for November 3, 1993, and that if a hearing did indeed take place, Deen would be notified.

# V.

Based on that advice and the fact that he did not hear from Respondent or anyone at Respondent's office, Deen did not make an appearance at the November 3, 1993 hearing. As a result, a Default Order to Establish Parent-Child Relationship was signed on November 10, 1993. Pursuant to the Default Order, income was withheld from Deen's paychecks to pay for child support.

#### VI.

Respondent had direct supervisory authority over Kelley and failed to make reasonable efforts to ensure that Kelley's conduct was compatible with Respondent's professional obligations as a lawyer. Respondent had direct supervisory authority over

Kelley at the time of the conduct in question. Respondent had knowledge of Kelley's conduct and/or misconduct and knowingly failed to take reasonable remedial action to avoid or mitigate the consequences of Kelley's conduct and/or misconduct. Respondent violated the Texas Disciplinary Rules of Professional Conduct ("TDRPC") and/or knowingly assisted or induced Kelley to do so and/or violated the TDRPC through the acts of Kelley.

#### VII.

The acts and/or omissions of the Respondent described in Paragraphs III - VI above, which occurred on or after January 1, 1990, constitute conduct in violation of Rules 5.03(a), 5.03(b)(2)(i), 5.03(b)(2)(ii), and 8.04(a)(1) of the TDRPC.

#### VIII.

The complaint that forms the basis of this cause of action was brought to the attention of the Office of the General Counsel of the State Bar of Texas by Constance Deen's filing of a complaint on or about May 11, 1994.

#### **Prayer**

WHEREFORE, PREMISES CONSIDERED, Petitioner the Commission for Lawyer Discipline respectfully prays that this Court discipline Respondent Hugh T. Echols, Sr., as the facts shall warrant; and that the Petitioner have all other relief to which it may show itself to be justly entitled, including costs of court and attorney's fees.
