DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF THE COURT:

COMES NOW, Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Marcus E. Faubion, Jr. (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Texas Government Code Annotated §81.001, *et seq.* (Vernon 1988 and supp. 1994), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint that forms the basis of this Disciplinary Petition was filed on or after May 1, 1992.

II.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Harris County, Texas, and therefore venue is appropriate in Harris County, Texas, pursuant to Rule

Disciplinary Petition/Faubion

3.03 of the Texas Rules of Disciplinary Procedure. Respondent may be served at his business address located at 9000 Gulf Freeway, Suite 100, Houston, Harris County, Texas, 77017.

III.

On or about June 25, 1993, Barry Wagenknecht (hereinafter called "Barry") was killed in an automobile accident. On or about July 1, 1993, Respondent signed a contingent fee contract with Shelley Wagenknecht (hereinafter called "Shelley"), Barry's wife and the designated administratrix of Barry's estate, to represent Shelley in a wrongful death action and in the matter of the estate. On or about July 6, 1993, Respondent also signed contingent fee contracts with Barry's daughter, Amber Wagenknecht (hereinafter called "Amber"), and Barry's parents, Ray and June Wagenknecht (hereinafter called "Ray" and June" respectively), to represent them in the wrongful death action and in the matter of the estate.

IV.

Thereafter, Amber, Ray, and June became concerned that Respondent's representation of Shelley was in direct conflict with their interests. By letter dated March 9, 1994, Amber, Ray, and June terminated Respondent's services. Respondent was requested to withdraw as their attorney of record and to forward their file to them. By letter dated March 14, 1994, Respondent refused to do so.

V.

Thereafter, Respondent settled the wrongful death action for \$525,000.00 in or around October 1994, and deposited the proceeds into his trust account. Respondent was aware that a dispute had arisen amongst Shelley, Amber, Ray, and June concerning each person's respective interest in the settlement. Even so, by check number 2216 and dated October 21, 1994, Respondent disbursed the remaining \$337,354.99 of the settlement to Shelley, rather than keeping the funds separate until the dispute could be resolved, and thereby protecting the interests of all of his clients, Shelley, Amber, Ray, and June.

VI.

In or around April 1995, Amber, Ray, and June filed a lawsuit, which was based on the same matter or a substantially related matter as the original wrongful death suit, against Respondent, Shelley, and the original defendants in the original wrongful death suit. Thereafter, on or about June 1, 1995, without the consent of Amber, Ray, and June, Respondent filed the Defendant's Original Answer on behalf of the Cloverleaf Volunteer Fire Department (hereinafter called "Cloverleaf"), even though he had represented Shelley, Amber, Ray, and June against Cloverleaf in the original wrongful death suit. Respondent also filed an answer on behalf of Craig Johnson, another of the defendants in the original wrongful death action.

VII.

The acts and/or omissions of the Respondent described in Paragraphs III-VI above, which occurred on or after January 1, 1990, constitute conduct in violation of Rules 1.14(c), 1.15(a)(3), 1.15(d), and 1.09(a)(3) of the Texas Disciplinary Rules of Professional Conduct.

VIII.

The complaint that forms the basis of this cause of action was brought to the attention of the Office of the General Counsel of the State Bar of Texas by Ray and June Wagenknecht's filing of a complaint on or about October 17, 1995.

<u>Prayer</u>

WHEREFORE, PREMISES CONSIDERED, Petitioner the Commission for Lawyer Discipline respectfully prays that this Court discipline Respondent Marcus E. Faubion, Jr., as the facts shall warrant; and that the Petitioner have all other relief to which it may show itself to be justly entitled, including costs of court and attorney's fees.
