**II.**

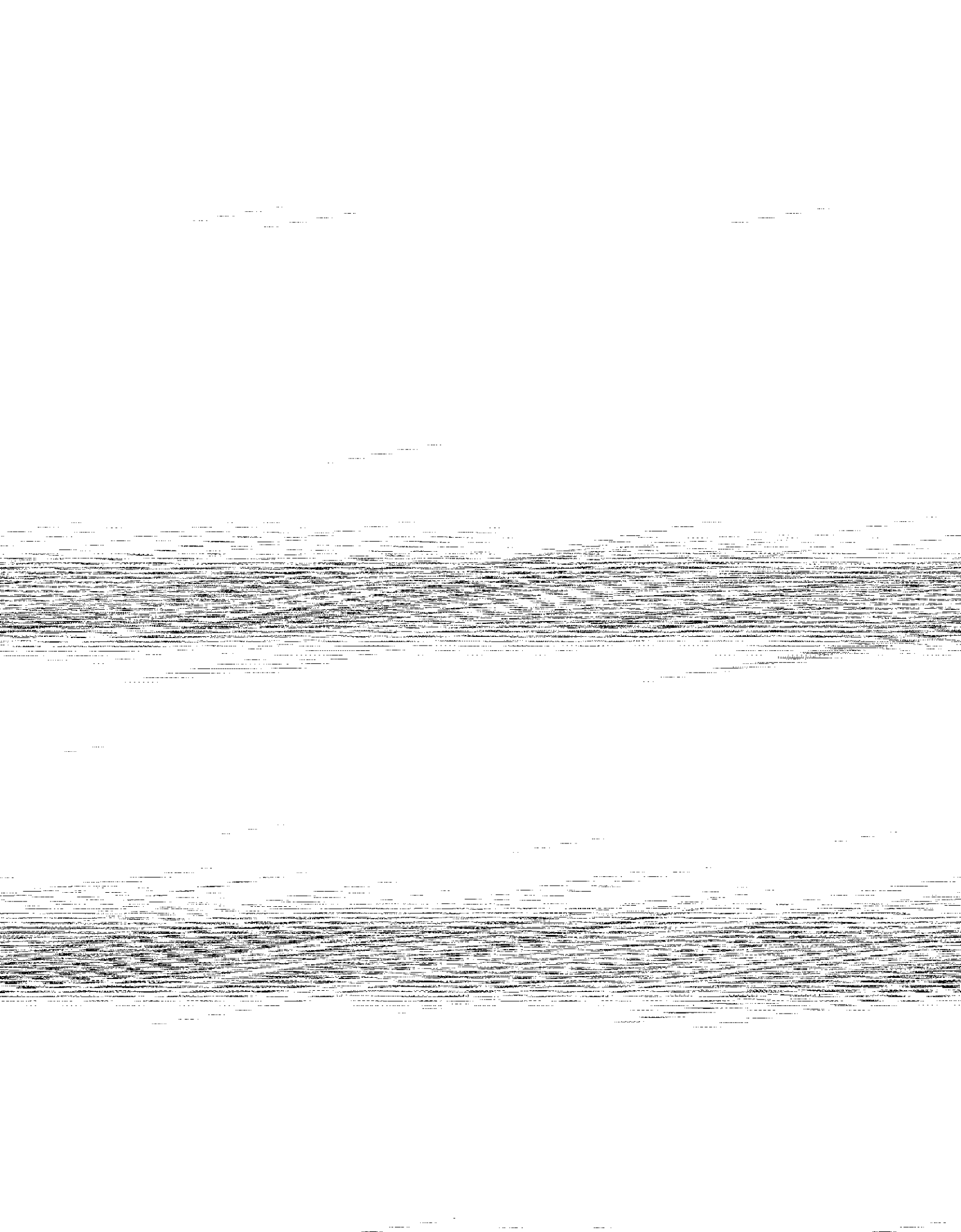
