## ORDER ESTABLISHING LEGISLATIVE RESEARCH COMMITTEE OF THE JUDICIAL COMMISSION ON MENTAL HEALTH

- 1. The Judicial Commission on Mental Health was created by the Supreme Court of Texas and the Texas Court of Criminal Appeals (the two Courts) on February 13, 2018 to develop, implement, and coordinate policy initiatives designed to improve the courts' interaction with—and the administration of justice for—children, adults, and families with mental health needs.
- 2. Recognizing that the Texas Legislature invests heavily each year in behavioral and mental health systems, the two Courts have a strong interest in studying the organization and practices of the Texas Judicial Branch related to behavioral and mental health needs.
- 3. The two Courts therefore order the establishment of a Legislative Research Committee to make relevant recommendations to the Texas Judicial Council. The following persons are appointed to serve as members:


