ORDER DETERMINING PLAINTIFF IS A VEXATIOUS LITIGANT

It is further ordered that the Clerk of the Court shall refuse the filing of any litigation presented by Rudy Cortez unless he obtains from the local administrative judge permitting the filing.

It is also further ordered that the Clerk of the Court shall forward a copy of this Order to

the Office of Court Administration of the Texas Judicial System in accordance with Section 11.104(a) of the Texas Civil Practice & Remedies Code for Plaintiff to be added to the List of Vexatious Litigants.
