AMENDED EMERGENCY ORDER REQUIRING REGISTRATION BY LAWYERS DISPLACED BY HURRICANE IKE TO CONTINUE REPRESENTING CLIENTS FROM TEMPORARY OFFICES IN TEXAS AND PERMITTING LAWYERS RETAINED BY A LEGAL SERVICES PROGRAM TO PRACTICE LAW THROUGH THE LEGAL SERVICES PROGRAM

### **ORDERED** that:

- 1. Until further order of this Court, and notwithstanding Texas Government Code chapter 81, subchapter G, an attorney holding a valid law license issued by Louisiana, who is in good standing with the Louisiana State Bar Association, is displaced from the attorney's home jurisdiction due to Hurricane Ike, and no later than November 17, 2008, completes and provides to the State Bar of Texas the Registration for Temporary Practice from Texas form attached to this order, is permitted to practice law until May 31, 2009, from a location in Texas as if the attorney were located in Louisiana. If the State Bar does not receive this completed form on or before November 17, 2008, the displaced attorney may be subject to prosecution for the unauthorized practice of law or other sanctions or actions. Upon written request submitted to the Membership Department of the State Bar of Texas, exceptional circumstances may be considered for untimely submission of the registration form. No fee is required for the registration described in this order.
- 2. An attorney, though not displaced from the attorney's home jurisdiction due to Hurricane Ike, who is retained by a legal services program funded by the Texas Access to Justice Foundation and no later than November 17, 2008 completes and provides to the State Bar of Texas the Registration for Temporary Practice from Texas form attached to this order, is permitted to practice law through the legal services provider until May 31, 2009. The retained attorney must hold a valid law license from another jurisdiction in the United States and be in good standing with the attorney's respective bar.
