ORDER SUSPENDING ATTORNEYS PURSUANT TO
ARTICLE XII, SECTION 8, STATE BAR RULES


The State Bar of Texas has notified the Court that the attorneys listed in Exhibit 1, attached, are licensed to practice law in Texas, that NOVEMBER is their Minimum Continuing Legal Education reporting month, and that they failed to comply with the requirements of Article XII, State Bar Rules. The Bar further advises that these attorneys have been properly notified, but that they have failed to cure the default.

Consequently, the listed attorneys are suspended as attorneys in Texas as of the date the list was generated, July 8, 2002. They shall not practice law in Texas until they have complied with the requirements of the Minimum Continuing Legal Education program and paid to the State Bar of Texas all fees and charges owed for their failure to comply timely.


II.
