

198th District Courts concerning Electronic Filing of Court Documents


ORDERED that:

TO LOCAL RULES OF COURT


THIS ADDENDUM IS HEREBY MADE A PART OF THE RULES OF PRACTICE IN THE 198TH & 216TH JUDICIAL DISTRICT COURTS WHICH WERE ORDERED FILED IN THE MINUTES OF THE COURT IN EACH COUNTY OF THE DISTRICT ON THE 2ND DAY OF JULY, 2001.

Any attorney practicing in the 198th & 216th District Courts, if practicable, shall have access to a fax machine and answering machine that will be operative 24 hours a day, seven days a week. Said numbers shall be provided to the Courts, the Clerks of Court, and all opposing counsel. All communications between the Courts and attorneys sent via fax to the numbers provided shall be deemed received. This does not include filing documents with the District Clerk, unless the District Clerk has implemented an Electronic Filing Plan.

This rule is effective immediately and all counsel shall provide these numbers to the Court and all counsel of record by July 15, 2003.
