**ORDER OF THE COURT APPROVING AN AMENDMENT TO THE FY 1990-1991  
GENERAL FUND BUDGET OF THE  
STATE BAR OF TEXAS**

WHEREAS, the State Bar of Texas has, by petition filed with the Supreme Court of Texas, on January 31, 1991, petitioned the Supreme Court of Texas to approve an amendment to its fiscal year 1990-1991 general fund budget; and

WHEREAS, the proposed budget amendment is as follows:

Approve the actions to add two newly created positions of Staff Attorney and Minority Affairs Liaison within the Office of the Executive Director. Unused salary funds are currently available and so no Budget Amendment is necessary to approve the expenditures of unbudget funds.

WHEREAS, the petition has been presented to and considered by the Supreme Court of Texas, and the Court being of the opinion that such budget amendment is necessary and should be approved as set forth herein;

It is, therefore, ORDERED that the proposed amendment to the budget of the State Bar of Texas for fiscal year 1990-1991 as set forth in the petition of the State Bar of Texas and submitted to this Court be, and the same is hereby, APPROVED, and that such budget be amended, effective this date.

I.

Such positions could not have been reasonably foreseen nor anticipated at the time such budget was originally presented to the Supreme Court for approval in 1990.


WHEREFORE, the State Bar of Texas respectfully requests the Supreme Court of Texas approve this proposed amendment to its 1990-1991 budget.
