WHEREAS the Supreme Court is advised by the State Bar that the attorneys listed in Exhibit 1 are those with a reporting month of NOVEMBER and


WHEREAS THE Supreme Court is advised by the State Bar that all conditions precedent by way of notices to the attorneys listed in Exhibit 1 have been met.



I.

NOW COMES the State Bar of Texas pursuant to Article XII, Section 8(C) and (D), State Bar Rules, and advises the Supreme Court of Texas that the attorneys whose names are listed in Exhibit 1 hereto have failed to comply with the requirements of the Minimum Continuing Legal Education program promulgated by this Court. All the attorneys shown in Exhibit 1 have the reporting month of NOVEMBER and have failed to comply with the requirements for the 1992 reporting period.

II.

The State Bar of Texas certifies that all notices of deficiencies have been sent to the attorneys listed in Exhibit 1, and the deficiency has not been cured to bring each listed attorney into compliance with the Minimum Continuing Legal Education requirements.
