ARTICLE XII, SECTION 8, STATE BAR RULES



WHEREAS the Supreme Court is advised by the State Bar that the attorneys listed in Exhibit 1 are those with a reporting month of DECEMBER and


WHEREAS THE Supreme Court is advised by the State Bar that all conditions precedent by way of notices to the attorneys listed in Exhibit 1 have been met.







I.
