ORDER SUSPENDING ATTORNEYS PURSUANT TO
ARTICLE XII, SECTION 8, STATE BAR RULES

WHEREAS the State Bar of Texas has notified the Supreme Court of Texas that the attorneys listed in Exhibit 1 hereto have failed to comply with the Minimum Continuing Legal Education requirements pursuant to Article XII, State Bar Rules, and

WHEREAS the Supreme Court is advised by the State Bar that the attorneys listed in Exhibit 1 are those with a reporting month of FEBRUARY and

WHEREAS THE Supreme Court is advised by the State Bar that all conditions precedent by way of notices to the attorneys listed in Exhibit 1 have been met.

It is therefore ORDERED that those attorneys licensed to practice law in the State of Texas listed in Exhibit (1) hereto are forthwith Suspended as attorneys in the State of Texas, and shall not practice law unless and until they have complied with the requirements of the Minimum Continuing Legal Education program and paid to the State Bar of Texas all fees and charges owed for their failure to comply timely,

Attached is the list of attorneys whose MCLE reporting month is February and who remain in non-compliance with the MCLE requirements as of the date printed on the top of this report.

We mailed each of these attorneys their Annual Reporting Affidavit during the first week of their birth month. Due to their non-compliance by the end of their birth month, we subsequently mailed to each of them a Non-Compliance Notice approximately the middle of the month following their birth month. The notice gave each of them 30 days to bring their record into compliance, and all of the attorneys included on the attached list failed to bring their record into compliance by the deadline. In addition, we have also placed a telephone call to each attorney on the list for whom we could obtain a phone number, and we either spoke with the attorney directly or left word with their office that if the non-compliance was not cured then they would be subject to suspension. All names shown on the list still remain in non-compliance as of this date.

We have also prepared the Petition and Suspension Order that would need to be presented to the Court in order to effect these suspensions.

Please review this list and the Petition and Suspension Order for the Supreme Court. I would ask that you sign the petition as soon as possible, and then we will walk this over to the Supreme Court.
