West Texas Legal Services is an approved legal assistance organization under the Emeritus Attorney Pro Bono Participation Program.


Enclosed are the following documents:


Dear Mr. Gaines:

As an applicant for the Emeritus Attorney Pro Bono Program under article XIII of the State Bar Rules:

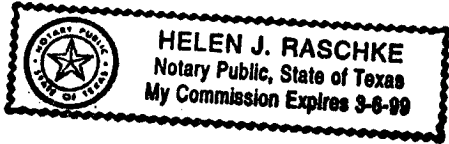
- (1) I have read and am familiar with the Code of Professional Responsibility as adopted by the Supreme Court of Texas, and will abide by its provisions;
