IN THE MATTER OF SEUNG CHAE KIM

ORDER

On this day, the Court considered the Motion for Acceptance of Resignation as Attorney and Counselor at Law of Seung Chae Kim, together with the Response of Chief Disciplinary Counsel to the Motion for Acceptance of Resignation as Attorney and Counselor at Law of Seung Chae Kim. The Court has reviewed said Motion and Response and finds that each meets the requirements of Part X of the Texas Rules of Disciplinary Procedure. In conformity with Part X, Section 10.02 of the Texas Rules of Disciplinary Procedure, the Court considers the detailed statement of professional misconduct contained within the Response of Chief Disciplinary Counsel to be deemed conclusively established for all purposes. The Court finds that Seung Chae Kim is resigning in lieu of discipline. The Court, being advised that the acceptance of the resignation is in the best interest of the public and the profession, hereby concludes that the following Order is appropriate.

IT IS ORDERED that the law license of Seung Chae Kim of Seoul Korea, State Bar Card Number 11417600, heretofore issued by the Court, be canceled and his name be dropped and deleted from the list of persons licensed to practice law in Texas.

IT IS FURTHER ORDERED that Seung Chae Kim immediately surrender his State Bar Card and Texas law license to the Clerk of the Supreme Court of Texas or file with the Court an affidavit stating the cause of his inability to do so.


IT IS FURTHER ORDERED that Seung Chae Kim be, and he is hereby permanently enjoined and prohibited from practicing law in the State of Texas, holding himself out as an attorney at law, performing legal services for others, giving legal advice to others, accepting any fee directly or indirectly for legal services, appearing as counsel or in any representative capacity in any proceeding in any Texas court or before any Texas administrative body (whether state, county, municipal, or other), or holding himself out to others or using his name in any manner in conjunction with the words "Attorney at Law", "Counselor at Law", or "Lawyer".

It is further **ORDERED** that Seung Chae Kim shall immediately notify each of his current clients in writing of this resignation. In addition to such notification, Seung Chae Kim is **ORDERED** to return any files, papers, unearned monies and other property belonging to clients and former clients in his possession to the respective clients or former clients or to another attorney at the client's or former client's request. Seung Chae Kim is **ORDERED** to file with the State Bar of Texas, 3710 Rawlins, Suite 800, Dallas, Texas 75219, within thirty (30) days of the date of the effective date of this Order an affidavit stating that all current clients have been notified of his resignation and that all files, papers, monies and other property belonging to all clients and former clients have been returned as ordered herein.


It is further **ORDERED** that Seung Chae Kim shall, on or before thirty (30) days from the effective date of this Order, notify in writing each and every justice of the peace, judge, magistrate, and chief justice of each and every court in which Seung Chae Kim has any matter pending of the terms of this Order, the style and cause number of the pending


matter(s), and the name, address and telephone number of the client(s) Seung Chae Kim is representing in Court. Seung Chae Kim is **ORDERED** to file with the State Bar of Texas, 3710 Rawlins, Suite 800, Dallas, Texas 75219, within thirty (30) days of the date of the effective date of this Order an affidavit stating that he has notified in writing each and every justice of the peace, judge, magistrate, and chief justice of each and every court in which he has any matter pending of the terms of this Order, the style and cause number of the pending matter(s), and the name, address and telephone number of the client(s) he is representing in Court.







RESPONSE OF THE CHIEF DISCIPLINARY COUNSEL
OF THE STATE BAR OF TEXAS
REGARDING
SEUNG CHAE KIM**

TO THE HONORABLE SUPREME COURT OF TEXAS:

I, Nancy M. Thursby, Assistant Chief Disciplinary Counsel of the State Bar of Texas, in accordance with Part X of the Texas Rules of Disciplinary Procedure, hereby file a response on behalf of the State Bar of Texas, acting by and through the Commission for Lawyer Discipline, to the Motion for Acceptance of Resignation as Attorney and Counselor at Law of Seung Chae Kim, received by the Office of the Chief Disciplinary Counsel on or about April 15, 1998. The acceptance of the resignation of Seung Chae Kim (hereinafter referred to as "Kim") is in the best interests of the public and the profession.

The following complaints are currently pending against Kim before an investigatory panel of the District Grievance Committee. The professional misconduct with which Kim is charged in the complaints currently pending before the investigatory panel is as follows:

A. Jae Kim vs. Seung Chae Kim - D0119710008

Complainant is a medical provider who treated one of Seung Chae Kim's clients, Soon Kim. The case was settled on or about July 14, 1997. Thereafter, Attorney Kim failed to pay Complainant for his services in the amount of \$5,815.20. Kim also failed to pay the client any of the settlement proceeds.

On December 3, 1997, a notice and copy of the complaint were sent to Seung Chae Kim. Attorney Kim was asked to reply to the complaint in writing within thirty (30) days of receipt, but he failed to respond and asserted no grounds for such failure.

The foregoing facts support a violation of Rules 1.14(b); 8.04(a)(3) and 8.04(a)(8) of the Texas Disciplinary Rules of Professional Conduct.


B. Soon Kim vs. Seung Chae Kim - D0119710038

In March of 1994, Seung Chae Kim was hired to represent Complainant in a personal injury claim. On July 14, 1995, the case was settled for \$21,500.00. Thereafter, the settlement check was received by Seung Chae Kim, but it was endorsed by someone other than Complainant, and cashed at a convenience store. The money was never deposited into Seung Chae Kim's trust account and Complainant never received her portion of the proceeds.

On December 3, 1997, a notice and copy of the complaint were sent to Seung Chae Kim. Attorney Kim was asked to reply to the complaint in writing within thirty (30) days of receipt, but he failed to respond and asserted no grounds for such failure.

The foregoing facts support a violation of Rules 1.14(a),(b); 8.04(a)(3) and 8.04(a)(8) of the Texas Disciplinary Rules of Professional Conduct.

In view of Seung Chae Kim's execution of his resignation as an attorney and counselor at law, and in anticipation of the Court's acceptance of same, the Chief Disciplinary Counsel does not anticipate going forward with the pending disciplinary proceedings before the investigatory panel and intends to dismiss the complaints upon entry of Order by the Supreme Court of Texas deleting Seung Chae Kim from the list of persons licensed to practice law in the State of Texas.




