II. Committee/Workgroup Reports

A. Re:SearchTX Committee

1. Discussion and consideration of the policy recommendations on Re:SearchTX to the Texas Supreme Court

Justice Simmons laid out the recommendations drafted by the group. She reminded the group that these recommendations had been revised since the last meeting and that weekly calls were held to allow all JCIT members to express their concerns and lay out any changes to the recommendations.

Justice Simmons reviewed each recommendation individually, then solicited feedback from the group. After some discussion, Justice Simmons also reminded the group that OCA is working with Tyler on the technical issues and that these recommendations were related to policies surrounding Re;SearchTX

Motion to adopt the recommendations as amended by Bob Wessels, seconded by Brian Quinn. 6 ayes (Simmons, Wessels, Hinde, Johnson, Quinn, VanMetre), 4 nays (Stanzione, Warren, Wells, Woodfin). *Motion carries.*
