[PROPOSED] ORDER DECLARING DR. MICHAEL (MIKHAIL) TYURIN A VEXATIOUS LITIGANT

After considering (a) Defendant Ritu Gupta's Motion to Declare Dr. Michael (Mikhail) Tyurin a Vexatious Litigant and (b) Defendants Robert E. Weitzel and Clint Corrie's Motion to Declare Dr. Michael (Mikhail) Tyurin a Vexatious Litigant (together, the "Motions"), the responses thereto, and evidence on file and submitted at the hearing, 1 the Court GRANTS the Motions.

Therefore, IT IS ORDERED that the Motions are GRANTED in all respects. For the reasons stated in the Motions and at the hearing, the Court FINDS that Defendants have satisfied the factors in Chapter 11 of the Texas Civil Practice and Remedies Code to show that Plaintiff is a vexatious litigant. The Court therefore DECLARES Plaintiff to be a vexatious litigant under Chapter 11 of the Texas Civil Practice and Remedies Code. IT IS ORDERED that Plaintiff take nothing against Defendants and their counsel by this suit and bear all costs therefrom.

IT IS FURTHER ORDERED that Plaintiff is prohibited from filing, *pro se*, the following:

And after hearing and granting the Defendants' Rule 91a Motions to Dismiss.

- (a) Any new litigation in any court in this state unless expressly granted permission from a local administrative judge first; and
- (b) Specifically, any new litigation in any court in this state unless expressly granted permission from a local administrative judge first against the following individuals and entities: (1) Ritu Gupta and any of her family members; (2) Southwestern Bell Telephone Company and any subsidiaries or affiliate companies of Southwestern Bell Telephone Company; (3) King & Spalding LLP, Jeremiah J. Anderson, and any other attorneys or employees at King & Spalding LLP; (4) Robert E. Weitzel and any of his family members; (5) Clint Corrie and any of his family members; (6) Akerman LLP and all employees and attorneys at Akerman LLP, including Wm. Bruce Stanfill; (7) B & H Foto & Electronics Corp. and any subsidiaries of or affiliate companies of B & H Foto & Electronics Corp; (8) C.M. Henkel III and any of his family members; and (9) Fritz, Byrne, Head & Gilstrap, PLLC and any attorneys or employees at Fritz, Byrne, Head & Gilstrap, PLLC.

As required by Texas Civil Practice & Remedies Code Section 11.104, the court clerk will provide a copy of this Order to the Office of Court Administrator of the Texas Judicial System.
