ORDERS ON CAUSES

15-1008 CITY OF RICHARDSON, TEXAS v. ONCOR ELECTRIC DELIVERY COMPANY LLC; from Dallas County; 5th Court of Appeals District (05-14-00843-CV, ___ SW3d ___, 08-11-15)

The Court reverses the court of appeals' judgment and reinstates the trial court's judgment.

Justice Green delivered the opinion of the Court.

Justice Blacklock did not participate in the decision.

16-0164 BARBARA BATY v. OLGA FUTRELL, CRNA, AND COMPLETE ANESTHESIA CARE, P.C.; from Ellis County; 10th Court of Appeals District (10-13-00175-CV, ___ SW3d ___, 11-19-15)

The Court reverses the court of appeals' judgment and remands the case to the trial court.

Justice Lehrmann delivered the opinion of the Court, in which Chief Justice Hecht, Justice Green, Justice Guzman, Justice Boyd, and Justice Devine joined.

Justice Johnson delivered a dissenting opinion, in which Justice Brown joined.

Justice Blacklock did not participate in the decision.

16-0560 LEE NICK MCFADIN, III v. BROADWAY COFFEEHOUSE, LLC; from Bexar County; 4th Court of Appeals District (04-16-00283-CV, ___ SW3d ___, 07-06-16) petitioner's motion for emergency temporary stay dismissed as moot joint motion for partial dismissal, treated as motion pursuant to Texas Rule of Appellate Procedure 56.3, granted

Pursuant to Texas Rule of Appellate Procedure 56.3, the Court severs the portion of the proceedings against Respondent Marcus Rogers, Trustee for Saks Children Trust a/k/a ATFL&L, a Texas Trust, from cause no. 16-0560 into case no. 18-0081, styled *Lee Nick McFadin, III v. Marcus Rogers, Trustee for the Saks Children Trust a/k/a ATFL&L, a Texas Trust.*

The Court reverses the court of appeals' judgment and remands the case to that court.

Justice Johnson delivered the opinion of the Court.
