ORDER ADJUDICATING PHILLIP SCHLITTLER A VEXATIOUS LITIGANT

On the 29th day of May, 2018, came on to be heard the Motion of Shirley Poppe Meyer and C. E. Clover, Jr. to Declare Phillip Schlittler a Vexatious Litigant and the Defendant Phillip Schlittler's Response thereto. The Movant Shirley Poppe Meyer appeared in person and by her attorney, C. E Clover, Jr. The Movant C. E. Clover, Jr. appeared in person. The Respondent, Phillip Schlittler appeared pro se by telephone

After hearing the evidence and argument of the parties, the Court finds that Respondent, Phillip Schlittler, is a Vexatious Litigant pursuant to Chapter 11 of the Texas Civil Practice & Remedies Code.

Accordingly, it is ORDERED, DECLARED and DECREED that:

- 1. Respondent, Phillip Schlittler, is a Vexatious Litigant pursuant to Chapter 11 of the Texas Civil Practice & Remedies Code;
- 2. Phillip Schlittler, a vexatious litigant, is prohibited from filing, in propria persona, a new litigation in a court in this state without first obtaining permission to do so from a local administrative judge pursuant to §11.102, Texas Civil Practice and Remedies Code;
- 3. The Clerk of this Court shall provide the Office of Court Administration of the Texas Judicial System a copy of this order not later than the 30th day after the date this order is signed;
- 4. The Office of Court Administration of the Texas Judicial System shall post on the agency's internet website that Phillip Schlittler has been adjudicated a vexatious litigant pursuant to Chapter 11 of the Texas Civil Practice & Remedies Code subject to a pre-filing order; and
- 5. All relief not granted herein is denied. This is a final and appealable order. All costs are assessed against the party incurring same.
