23-0384 AMERICAN MIDSTREAM (ALABAMA INTRASTATE), LLC v. RAINBOW ENERGY MARKETING CORPORATION; from Harris County; 1st Court of Appeals District (01-20-00055-CV, 667 SW3d 837, 04-13-23)

The Court reverses the court of appeals' judgment, renders judgment in part, and remands the case to the trial court.

Justice Sullivan delivered the opinion of the Court.
(Justice Devine not participating)

23-0460 JARED BUSH, JR. v. COLUMBIA MEDICAL CENTER OF ARLINGTON SUBSIDIARY, L.P. D/B/A MEDICAL CITY ARLINGTON AND HCA INC.; from Tarrant County; 2nd Court of Appeals District (02-22-00319-CV, 692 SW3d 606, 04-20-23)

The Court reverses the court of appeals' judgment and remands the case to the trial court.

Justice Huddle delivered the opinion of the Court, in which Chief Justice Blacklock, Justice Lehrmann, Justice Boyd, Justice Busby, Justice Young, and Justice Sullivan joined.

Justice Bland filed a dissenting opinion, in which Justice Devine joined.

Justice Busby delivered the opinion of the Court.

Justice Bland filed a concurring opinion, in which Chief Justice Blacklock and Justice Devine joined.

The Court reverses the court of appeals' judgment and renders judgment.

Chief Justice Blacklock delivered the opinion of the Court.
