On this day came to be considered Defendant's Motion to Declare Plaintiff a Vexatious Litigant. After considering the pleadings of the parties and the argument of counsel, the Court is of the opinion that the motion has merit and should be granted. Therefore, it is

**ORDERED** that Defendant's Motion to Declare Plaintiff a Vexatious Litigant is **GRANTED**. Plaintiff Luis S. Lagaite, TDCJ # 762508, is hereby **DETERMINED TO BE A VEXATIOUS LITIGANT**.

Therefore, Plaintiff is ordered to furnish security in the amount of \$5,000. The amount must be furnished to the Court by March 1, 2015. Should Plaintiff fail to furnish such security within the time set by this Order, the above referenced and numbered cause is **DISMISSED**. Should the case be dismissed upon its merits, Plaintiff shall pay Defendant's reasonable expenses incurred in or in connection with this litigation, including costs and attorney's fees. It is further

**ORDERED** that the Clerk of the Court shall refuse the filing of any litigation presented by Luis S. Lagaite, unless he obtains an order from the local administrative judge permitting the filing. It is further

**ORDERED** that the Clerk of the Court shall forward a copy of this Order to the Office of Court Administration of the Texas Judicial System in accordance with Section 11.104(a) of the Texas Civil Practice & Remedies Code.


