



## OFFICE OF COURT ADMINISTRATION Trial Court Judicial Data Management System File Specification – Justice of the Peace Courts

The XML file for the Justice of the Peace court report is detailed below. (Note: This is not a correction file so the correction tags will be blanks). Sample contents are included within the XML tag, and explanatory information is shown outside each set of brackets <> as applicable. The sample contents of the fields in this document do not create an in-balance report when loaded. The numbers in this example are merely examples.

**File Description:** The file is broken down into Record Header, Number of Reported Lines and Line Details.

**Record Header** information relates to the header of the data reported to uniquely identify the submitted file and will be committed to Records Header Table in the database.

**NumofLinesReported** will identify total lines reported on this xml file.

**LineDetails** identifies the actual data conveyed through this file transfer. The descriptive information relates the line details and data elements to the actual report completed either on paper or on line.

Note: The `xsi:nil="true"` attribute is listed on a few optional fields. Only use that attribute when the field is left blank. If the field will contain a value, then do not include the `xsi:nil="true">` attribute.
